Independent Examiner's Report to the Trustees of New Monkland Parish Church

I report on the accounts of the charity for the year ended 31 December 2018 which are set out herewith

Respective responsibilities of trustees and examiner

The charity trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Very grateful thanks are also conveyed to all who help to fund, maintain and clean our historic Auld Grey Kirk and Hall, your contribution is greatly appreciated.

We were blessed in the course of the year with many generous donations for the repair of our Sanctuary windows – may God bless the donors for their kindness.

Our Cafe Crew and Cafe Committee work to make sure that our Outreach Cafe serves the needs of our people. Our Social Committee works creatively through the year and it was extremely satisfying to see their hard work so greatly supported and richly rewarded - likewise the hard work of the Christmas Fayre Committee.

Our robust Safeguarding Policy is overseen by our diligent Safeguarding Officer Mrs Margaret Carmichael on behalf of the Kirk Session and very grateful and thanks are extended to our Sunday School Leaders and helpers for their committed and excellent work - and also to the excellent and dedicated leaders of our uniformed organisations - they are an inspiration to us all.

It's a privilege to recognize the work of our Session Clerk, Mrs Margaret Millar and our Treasurer, Mr. Derek Croall.

I invite you to take some time to read through these pages and intentionally rejoice, reflect and remember God's goodness to us.

As ever, the year ahead presents both interesting and diverse challenges and exciting opportunities and I call on you to remember that our God is not just a God of the past. He's very much a God of the present and of the future and I firmly believe that the best in our near four hundred year old history is yet to come.

Trustees' Annual Report

Year ended 31 December 2018

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Quoad Omnia Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session which meets a minimum of nine times a year is responsible for all matters within the church

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond. New Monkland Parish Church holds one service on Sunday mornings at 10 am. There is a Sunday School and Bible Class, Boys Brigade and Guides. The Guild meets fortnightly and an outreach cafe takes place weekly on Wednesdays in the Church Hall. The local toddler group meets twice per week and the AA meets weekly in the Church Hall. An annual Fayre is held and a variety of social events take place throughout the year.

Financial Review

The principal source of income remains regular giving and associated tax recovered under Gift Aid.

The total offerings figure of £54,294, excluding tax recovered, shows an increase of £2140 on the previous year's £52,154.

Gift Aid Tax recovered from HMRC in respect of the calendar year 2017 was £9,024, an increase of £432 on the previous year and again we thank Margaret Blades for her work in this regard.

Promotion of the Church of Scotland's National Stewardship Campaign and of the benefits of the Gift Aid scheme continued in 2018 and culminated in the Barn Dance held once again at Gaindykehead Farm in late October. Guest of honour was the Church of Scotland's recently appointed Stewardship Promoter, David Lynch, who supplied us with some Stewardship material for distribution on the evening.

The annual Christmas Fayre was held again in November and raised £3,390, an increase of £326 on 2017's £3,064

Carol Singing around the village in December raised £210 which was donated to the Food Bank in Airdrie. A retiral offering of £552 raised at the Carols by Candlelight service has been allocated to the benevolent fund. We recognize that hardship does still exist within the village and payment has already been made from this fund at the minister's discretion. The Watchnight service raised a further £388 which will go to the Disasters Emergency Committee.

Income from the weekly outreach café was £5,909, down from £6,485 in 2017. As always, thanks go to all those who work in, or contribute to the café.

In June 2018 we were visited by Mr Keith Fraser, the nephew and executor of the will of Mr Alex Mackintosh, a former elder of the church who re-located to Auchterarder many years ago.

Mr Mackintosh had very generously bequeathed the sum of £20,000 to the church and Mr Fraser presented Rev. Jackson with a cheque in that amount.

As we are all aware, to the church windows were vandalised in August.

The window repairs and protection cost £3,060. £464 was recovered from Aviva Insurance and donations totalling £1,600 from church members and others were gratefully received towards the cost of repair. The repairs were paid from the Fabric Fund.

Roof repairs to the Raebog Hall costing £780 were required in May due to rotting timbers. A further repair in July due to vandalism cost £360 pounds.

Electrical inspections, testing and preparing a report for the church and hall cost £1,140.

Further repairs to the patio at the manse were required as it remained in a dangerous condition. The work was completed at a cost of £500. There were no other significant repairs carried out at the manse.

The Heras Fencing remains in position at the church hall to protect the public from the unsafe wall at the dwelling house to the east of the hall. The situation there remains unchanged.

Cleaning of the Hall cost £532.

Heating and lighting costs for the year were £6,124 - slightly under budget.

Ministries and Mission Allocation for 2018 of £39,213 has been paid in full by standing order. The allocation for 2019 will be £43,184 – an increase of £3,971 on the 2018 allocation.

Presbytery dues for 2019 are £1,204 compared to £1,002 in 2018.

Overall, total fund balances increased by £ 27,977.47 to £159,885.

RBS continue to operate as our principle bankers. Although our account has now transferred to the Coatbridge branch, our account details remain unchanged.

Our current account with the Bank of Scotland remains active.

During the year £50,000 was transferred to the Church of Scotland Deposit Fund.

Finally, I would like to thank Mrs Wendy Ward who has agreed once again to carry out the independent examination of these accounts. Her willingness to carry out this essential role is greatly appreciated.

Reserves Policy

At the year - end the total of unrestricted designated cash funds was £154,533.57. Due to the age of the church building it is difficult to assess the level of reserves which require to be held. In common with most other churches, our reserves are dictated by the level of expenditure in any given year against income from freewill offerings and fundraising.

The General Fund balance of £139,681 is consistent with the Trustees stated policy that the General Fund balance should be sufficient to reasonably allow for any unforeseen expenditure.

The Fabric Fund sits at £9,004 to allow for ongoing upgrade to the manse.

We are not aware of any major repairs likely to be required to the Organ in the coming year, and consequently no provision has been made.

The Social Fund sits at £786 and the Youth Fund remains at £251.

£200 was paid from the Benevolent Fund which now sits at £2,344.

The Guild, Sunday School, Bible Class and Missionary Partner each have their own funds to enable them to fulfil their responsibilities.

The Church also holds £5,352 of restricted funds to be used for the maintenance of specific graves.

Statement of Trustees Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Bible Class: Income from collections & fundraising used for purchase of materials and taking part in appropriate events

Missionary Fund: Funds raised for Missionary Partner Social Fund: Self funding of church social events

Purposes of Restricted Funds

Trust Fund: Set up many years ago, the income from which was intended to be used for maintenance of specific graves. Fell into disuse when income became insufficient to fulfil obligation.
